An act to amend Sections 1247.2, 1247.4, 1247.6, 1247.63, 1247.64, 1247.8 of, to add Section 1247.61 to, and to add and repeal Section 1247.62 of, the Business and Professions Code, relating to healing arts, and declaring the urgency thereof, to take effect immediately.

## LEGISLATIVE COUNSEL'S DIGEST

SB 112, as introduced, Oropeza. Hemodialysis technicians.

Existing federal law sets forth certain requirements that dialysis facilities must meet in order to be certified under the Medicare Program, including a requirement that patient care dialysis technicians at those facilities complete a specified training program, have a high school diploma or equivalency, be certified under a state or national certification program, and meet all applicable state requirements, as specified.

Existing law provides for the licensure and regulation of various clinical laboratory personnel and makes a violation of those provisions a crime. Within that law, the Hemodialysis Technician Training Act prohibits a person from providing services as a hemodialysis technician without being certified by the State Department of Public Health as meeting certain requirements, as specified.

This bill would revise those requirements and prohibit a person from providing services as a hemodialysis technician without (1) being certified by a specified national certification program or (2) having a high school diploma or equivalency or 4 years of specified work experience, successfully completing a training program meeting specified requirements, and passing a standardized test, as specified. The bill would require technicians certified by the department as of the

bill's operative date to meet those requirements by April 15, 2010, as specified. The bill would make other conforming and technical, nonsubstantive changes.

By changing the definition of a crime, this bill would impose a state-mandated local program.

The California Constitution requires the state to reimburse local agencies and school districts for certain costs mandated by the state. Statutory provisions establish procedures for making that reimbursement.

This bill would provide that no reimbursement is required by this act for a specified reason.

This bill would also declare that it is to take effect immediately as an urgency statute.

*The people of the State of California do enact as follows:*

- 1 SECTION 1. The Legislature hereby finds and declares all of  
2 the following:
- 3 (a) In April 2008, the Centers for Medicare and Medicaid  
4 Services (CMS) issued final regulations, the Conditions for  
5 Coverage of End-Stage Renal Disease Facilities (Conditions for  
6 Coverage), at Part 494 of Title 42 of the Code of Federal  
7 Regulations, establishing conditions that dialysis facilities must  
8 meet to be certified under the Medicare Program.
- 9 (b) The Conditions for Coverage require hemodialysis  
10 technicians providing services at dialysis facilities to be certified  
11 under a state certification program or a national commercially  
12 available certification program by a specified date.
- 13 (c) The Conditions for Coverage further require hemodialysis  
14 technicians providing services at dialysis facilities to, among other  
15 things, have a high school diploma or equivalency and have  
16 completed a specified training program.
- 17 (d) More than 6,000 persons provide services as hemodialysis  
18 technicians in California.
- 19 (e) Only three national commercially available certification  
20 programs have been approved by CMS.
- 21 (f) Therefore, it is the intent of the Legislature to revise the  
22 Hemodialysis Technician Training Act to ensure that hemodialysis  
23 technicians meet the requirements of the Conditions for Coverage

1 so that dialysis facilities in this state may continue to employ those  
2 technicians.

3 SEC. 2. Section 1247.2 of the Business and Professions Code  
4 is amended to read:

5 1247.2. For the purpose of this article, the following terms  
6 have the following meaning:

7 (a) “Immediate supervision” means supervision of dialysis  
8 treatment in the same room in which the dialysis treatment is being  
9 performed.

10 (b) “Department” means the State Department of *Public Health*  
11 *Services*.

12 (c) “Hemodialysis technician” means an unlicensed health care  
13 provider who is employed by a hemodialysis clinic or unit for the  
14 purpose of participating in the direct treatment of patients  
15 undergoing hemodialysis.

16 SEC. 3. Section 1247.4 of the Business and Professions Code  
17 is amended to read:

18 1247.4. The department shall adopt ~~rules and regulations, by~~  
19 ~~July 1, 2001, prescribing minimum training standards for~~  
20 ~~hemodialysis technicians who are certified pursuant to paragraphs~~  
21 ~~(2), (3), and (4) of subdivision (a) of Section 1247.6~~ *it deems*  
22 *necessary to implement this article.*

23 SEC. 4. Section 1247.6 of the Business and Professions Code  
24 is amended to read:

25 1247.6. (a) Except during training under immediate  
26 supervision, *and except as provided in Section 1247.62*, no person  
27 shall provide services as a hemodialysis technician without ~~meeting~~  
28 ~~one or more~~ *being certified by the department as a Certified*  
29 *Hemodialysis Technician (CHT). To be certified by the state as a*  
30 *CHT, a person must meet one of the following two requirements:*

31 (1) Certification by the department as having been certified by  
32 ~~the one of the following:~~

33 (A) ~~The Board of Nephrology Examination for Nurses and~~  
34 ~~Technicians Examiners for Nursing and Technology (BONENT).~~

28 1247.61. To be certified by the department as a Certified  
29 Hemodialysis Technician (CHT), a person shall meet all three of  
30 the following requirements:

31 (a) Have a high school diploma or equivalency, or have greater  
32 than four years of work experience in dialysis as of October 14,  
33 2008.

34 (b) Have successfully completed a training program that is  
35 approved by the medical director and governing body of a  
36 hemodialysis clinic or unit, under the direction of a registered  
37 nurse, focused on the operation of kidney dialysis equipment and  
38 machines, providing direct patient care, and communication and  
39 interpersonal skills, including patient sensitivity training and care  
40 of difficult patients. For purposes of this subdivision, a person

1 “successfully completes a training program” if he or she completes  
2 all didactic portions of the program and demonstrates competency  
3 in the knowledge and skills provided by the program.

4 (1) The training program shall include all of the following  
5 subjects:

6 (A) Principles of dialysis.

7 (B) Care of patients with kidney failure, including interpersonal  
8 skills.

9 (C) Dialysis procedures and documentation, including initiation,  
10 proper cannulation techniques, monitoring, and termination of  
11 dialysis.

12 (D) Possible complications of dialysis.

13 (E) Water treatment and dialysate preparation.

14 (F) Infection control.

15 (G) Safety.

16 (H) Dialyzer reprocessing, if applicable.

17 (2) A community or corporate-based training program, or a  
18 training program offered by an educational institution, is acceptable  
19 if the program meets the requirements of this subdivision.

20 (3) A person employed as a hemodialysis technician by a  
21 hemodialysis clinic or unit for more than two years as of October  
22 14, 2008, who does not have documentation of having successfully  
23 completed a training program meeting the requirements of this  
24 subdivision, shall be deemed to be in compliance with this  
25 subdivision by doing both of the following:

26 (A) Passing a written exam, offered by a hemodialysis clinic or  
27 unit, covering the subjects listed in paragraph (1).

28 (B) Passing a skills checklist through observation by a registered  
29 nurse of the technician’s skills.

30 (c) Pass a standardized test that is approved by the department  
31 and that covers, at a minimum, the subjects listed in paragraph (1)  
32 of subdivision (b). This test shall be administered in a proctored  
33 environment by an independent examiner. For purposes of this  
34 subdivision, independent examiners may include representatives  
35 appointed by End-Stage Renal Disease Network 17, End-Stage  
36 Renal Disease Network 18, the California Dialysis Council, or any  
37 private testing organization approved by the department for that  
38 purpose.

39 SEC. 6. Section 1247.62 is added to the Business and  
40 Professions Code, to read:

1 1247.62. (a) Except as provided in subdivision (b), Section  
2 1247.6 shall not apply to a person certified by the department as  
3 a hemodialysis technician as of the operative date of this section.

4 (b) Notwithstanding Section 1247.63, the certification of a  
5 person described in subdivision (a) shall be valid until April 15,  
6 2010. That person shall, on or before that date, obtain a new  
7 certification under Section 1247.6 in a manner prescribed by the  
8 department.

9 (c) This section shall become inoperative on July 1, 2010, and,  
10 as of January 1, 2011, is repealed, unless a later enacted statute,  
11 that becomes operative on or before January 1, 2011, deletes or  
12 extends the dates on which it becomes inoperative and is repealed.

13 SEC. 7. Section 1247.63 of the Business and Professions Code  
14 is amended to read:

15 1247.63. (a) Certification of a hemodialysis technician issued  
16 by the department pursuant to subdivision (a) of Section 1247.6  
17 shall be valid for four years.

18 ~~(b) Those hemodialysis technicians certified by the department  
19 or the Board of Nephrology Examination for Nurses and  
20 Technicians (BONENT) before January 1, 1995, shall, before  
21 January 1, 1996, apply to renew their certification, or in the case  
22 of those technicians certified by the Board of Nephrology  
23 Examination for Nurses and Technicians (BONENT) obtain  
24 department certification, by submitting the fee required by  
25 subdivision (n) of Section 1300 and proof of previous certification.  
26 The department shall automatically renew the certification of those  
27 hemodialysis technicians who were certified before January 1,  
28 1995, and who apply for renewal pursuant to this subdivision.~~

29 ~~(e) For renewals occurring on or after January 1, 1996, a~~

30 ~~(b) A certified~~ hemodialysis technician applying for renewal of  
31 his or her certification shall submit proof that he or she has obtained  
32 30 hours of in-service training or continuing education in dialysis  
33 care or general health care as a requirement for the renewal of his  
34 or her certification.

35 SEC. 8. Section 1247.64 of the Business and Professions Code  
36 is amended to read:

37 1247.64. A hemodialysis technician may obtain the in-service  
38 training or continuing education required by subdivision ~~(e)~~ (b) of  
39 Section 1247.63 from one or more of the following sources:

1 (a) Health-related courses offered by accredited postsecondary  
2 institutions.

3 (b) Health-related courses offered by continuing education  
4 providers approved by the California Board of Registered Nursing.

5 (c) Health-related courses offered by recognized health  
6 associations if the department determines the courses to be  
7 acceptable.

8 (d) Health-related, employer-sponsored in-service training or  
9 continuing education programs.

10 SEC. 9. Section 1247.8 of the Business and Professions Code  
11 is amended to read:

12 1247.8. Each hemodialysis unit or clinic shall have information  
13 available for inspection by the department survey teams which  
14 ~~shows the local training program and competency test and the~~  
15 ~~names of all hemodialysis technicians and hemodialysis technician~~  
16 ~~trainees employed in the unit or clinic. Where a hemodialysis unit~~  
17 ~~or clinic does not adopt a local training program and test, it shall~~  
18 ~~provide proof~~ *verifies* that the hemodialysis technicians employed  
19 *at the unit or clinic* meet the requirements of subdivision (a) of  
20 Section 1247.6.

21 SEC. 10. No reimbursement is required by this act pursuant to  
22 Section 6 of Article XIII B of the California Constitution because  
23 the only costs that may be incurred by a local agency or school  
24 district will be incurred because this act creates a new crime or  
25 infraction, eliminates a crime or infraction, or changes the penalty  
26 for a crime or infraction, within the meaning of Section 17556 of  
27 the Government Code, or changes the definition of a crime within  
28 the meaning of Section 6 of Article XIII B of the California  
29 Constitution.

30 SEC. 11. This act is an urgency statute necessary for the  
31 immediate preservation of the public peace, health, or safety within  
32 the meaning of Article IV of the Constitution and shall go into  
33 immediate effect. The facts constituting the necessity are:

34 To avoid a critical shortage of hemodialysis technicians meeting  
35 the requirements of the Medicare Program Conditions for Coverage  
36 of End-Stage Renal Disease Facilities, it is necessary that this act  
37 take effect immediately.
